## Frequently Asked Questions: IRAP Assessor Training

**I work for a State Government Department and utilise the ISM, am I eligible to become an IRAP Assessor?**

Yes, as long as you can demonstrate a minimum of five years of technical ICT experience with at least two years of information security experience securing systems using the Australian Government Information Security Manual (ISM) and supporting publications including the Australian Government Protective Security Policy Framework (PSPF) and supporting publications.

**Are you offering more course dates in the future?**

We have received overwhelming interest in our IRAP Assessor Training Course, and we are adding new dates on an ongoing basis. The best way to stay informed about new dates is to [express your interest](#), and we will email you with information once new spaces and dates are added.

Training is delivered in-person or virtually depending on COVID and border restrictions.

**Do you hold training in other states?**

We can deliver the course interstate once we receive significant expressions of interest from one state, depending on COVID and border restrictions. Please fill out [this form](#) on our website, nominate your state and let us know in the comments that you would like to be notified once a training session is available in your state.

**Several people in my organisation would like to do the course. Can you come to us?**

We can bring the course to you if there are 10 people or more from your organisation who are prepared to do the course and depending on availability of trainers in your state. This will be at a negotiated time and cost. This can be delivered virtually and in-person depending on COVID and border restrictions.

**I would like to become an ASD-endorsed IRAP assessor. Can I take this course and sit the exam if I don't yet have all the requirements?**

You can complete the IRAP Assessor Training Course and sit the exam provided you meet the other requirements within 12 months of completing the exam.

**Am I permitted to complete the IRAP training without sitting the exam?**

Yes, you can complete the IRAP Readiness Training Program without sitting the exam for a reduced cost of \$3,750 + GST for in-person or \$3,600 + GST for virtual training.

**When and where will the exam be held?**

The exam will be held on the fifth day of your training via an online platform whether you are attending virtual or in-person training.

## How long does the exam take?

You are permitted up to 120 minutes to complete the exam. If English is an additional language (EAL) you are permitted a further 20 minutes to complete the exam.

## How many chances do I have to pass the exam?

You have two chances to pass the exam: on the fifth day of training, and a second time no sooner than 4 calendar months from the date of the original exam. The second exam is at no extra cost.

## How long will it take to receive the exam results?

Participants will receive their results within 30 days of completion.

## Do you take credit card payments?

Yes, we can take credit card payments for your training. The link to pay by credit card will be on the bottom left of your invoice. Credit card payments incur a 1.75% credit card fee.
